Kindly sell all of Mr. Jewett's stocks and make a check payable to him. If you wish, you may stipulate that the check be deposited into his savings account, number 107-632, Security Pacific National Bank, P.O. Box 4008, Saticoy, California 93003.

Recently Mr. Jewett had surgery at the Santa Paula Memorial Hospital in Santa Paula, California. His doctor there was Dr. Emery. Then he stayed two months at the Twin Pines Convalescent Home, 250 March Street, Santa Paula, 93060. Since the Twin Pines does not have intermediate care, we transferred him to the Pleasant Valley Rehabilitation & Convalescent Hospital, 5225 South "J" Street, Oxnard, California 93030, which will accept MediCal patients when all but \$1,500.00 of his money has been used for his care.

Mr. Jewett only at times is responsible for his actions. We are attempting to keep him as comfortable and happy as possible. If you should wish a confirmation of his condition, feel free to contact the above institutions or persons. Also, you may wish to contact his sister-in-law, Miss Edith Rinell, 740 Bismark Avenue, Ventura, California 93003, or his nephew, Mr. John Rinell, 527 Patricia Dr., San Luis Obispo, California 93401.

I appreciate the concern you have for Mr. Jewett's welfare and hope that I have given the information you need. Naturally, if there is anything else you need to know, I shall be happy to comply with your requests.
