6 LAST WILL AND TESTAMENT  
7 OF  
8 LE ROY ROBERTS JEWETT

10 I, LE ROY ROBERTS JEWETT, of Yucca Valley, California, declare  
11 this to be my last will and testament, and revoke all former wills  
12 and codicils heretofore made by me.

13 FIRST: I declare that I am not now married; that I was former-  
14 ly married to MARGARET JEWETT who died in 1959; I was later married  
15 to MARGE JEWETT and said marriage was terminated by divorce in 1962  
16 in Nevada. I have no children or children of deceased children.

17 SECOND: I direct my executor to pay my just debts, last ill-  
18 ness and funeral expenses.

19 THIRD: I direct that my body be cremated, and my executor is  
20 hereby directed to pay to the Yucca Valley Masonic Lodge the sum  
21 of \$200.00 for a Masonic Burial Service. I do not wish any further  
22 burial service at my grave in the 29 Palms Cemetery.

23 FOURTH: It is my intention to dispose of all property which  
24 I am entitled to dispose of by will.

25 FIFTH: I give, devise and bequeath my automobile to LENNERT  
26 HOLMQUIST. In the event he predeceases me this bequest shall go  
27 to his mother DORIS HOLMQUIST.

28 SIXTH: I give, devise and bequeath all of the rest, residue  
29 and remainder of my estate, real and personal, and wherever situated,  
30 including all failed and lapsed bequests, to the following persons:

31 (a) One-third (1/3) thereof to JOHN RINELL, 4317 Gayle Street,  
32 Tarzana, California. If he predeceases me, this one-third (1/3)

1 shall go to DORIS HOLMQUIST and EDITH RINELL in equal shares or to  
2 whichever one of said persons is living at my death, if either one  
3 of them predeceases me.

4 (b) One-third (1/3) thereof to DORIS HOLMQUIST, 8270 Denver  
5 Street, Ventura, California. If she predeceases me, this one-third  
6 (1/3) shall go to JOHN RINELL and EDITH RINELL, in equal shares,  
7 or to whichever one of said persons is living at my death, if  
8 either one of them predeceases me.

9 (c) One-third (1/3) thereof to EDITH RINELL, 10184 Camulos  
10 Avenue, Montclair, California. If she predeceases me this one-  
11 third (1/3) shall go to JOHN RINELL and DORIS HOLMQUIST, in equal  
12 shares, or to whichever one of said persons is living at my death,  
13 if either one of them predeceases me.

14 The persons named in this paragraph SIXTH are relatives of my  
15 former wife MARGARET JEWETT who is now deceased.

16 SEVENTH: Except as otherwise provided for in this will, I  
17 have intentionally and with full knowledge omitted to provide for  
18 my heirs who may be living at my death.

19 EIGHTH: If any devisee, legatee or beneficiary under this  
20 will shall directly or indirectly contest it or any of its parts  
21 or provisions, any share or interest given to that person shall  
22 be revoked and augment proportionately the shares of such of the  
23 devisees, legatees and beneficiaries as shall not have joined or  
24 participated in said contest.

25 NINTH: I appoint as executor of this will SECURITY FIRST  
26 NATIONAL BANK, to act without bond. I hereby authorize my executor  
27 to sell, or lease, property of my estate, subject to such order of  
28 court as may be required by law and to hold, manage and operate any  
29 business belonging to my estate at the risk of my estate.

30 My safe deposit box is presently in the Yucca Valley Branch  
31 of Security First National Bank, now known as Security Pacific  
32 National Bank.
